Subject: Contract: Alta Group, Inc. for the T1 Corporation Yard Maintenance Building Upgrade Project at 1326 Allston Way, and the T1 Marina Corporation Yard Maintenance Building Upgrade Project at 201 University Avenue

RECOMMENDATION

Adopt a Resolution:

- 1. Approving plans and specifications for the T1 Corporation Yard Maintenance Building Upgrade Project and the T1 Marina Corporation Yard Maintenance Building Upgrade Project, Specification No.19-1 1302 -C;
- 2. Accepting the bid plus bid alternate of Alta Group, Inc. as the lowest responsive and responsible bidder;
- 3. Authorizing the City Manager to execute a contract and any amendments, extensions or other change orders until completion of the project in accordance with the approved plans and specifications, for an amount not to exceed \$1,011,006 which includes a contingency of \$131,871.

FISCAL IMPACTS OF RECOMMENDATION

Funding is available from the T1 Fund. No other funding is required, and no other projects will be delayed due to this expenditure. These projects were recommended and approved as part of the original T1 project proposals.

CURRENT SITUATION AND ITS EFFECTS

Following the design process, the Projects' construction documents were completed and advertised for bids on Monday, March 9, 2020. Bids were opened on Thursday, April 9, 2020. The City received two bids, \$879,135 from Alta Group (Base bid \$668,712 plus bid alternate \$210,423) and \$991,500 from Bay Construction (Base bid \$792,500 plus bid alternate \$199,000). Alta Group, Inc. was the lowest responsive and responsible bidder and their references were provided and checked out satisfactorily. Based on the results, staff recommends that a construction contract for the T1 Corporation Yard Maintenance Building Upgrades and the T1 Marina Corporation Yard Maintenance Building Upgrades projects be awarded to Alta Group, Inc.

The contract will be subject to the Community Workforce Agreement.

BACKGROUND

The City's Corporation Yard houses hundreds of employees and over one hundred city owned vehicles, including trucks, street sweepers, and other heavy equipment. The Equipment Maintenance Building is considered a critical service building that provides service to all City vehicles. This project includes a comprehensive upgrade and replacement of the aging electrical infrastructure, as well as compliance with the most current electrical codes. In addition the project includes structural reinforcement to the roof structure, and replacement of the existing generator at the Corporation Yard Equipment Maintenance Building.

The Berkeley Marina is a popular destination for community members and tourists to enjoy. The Marina Corporation Yard houses maintenance staff and equipment to service over one hundred acres of park space, seven miles of trails, picnic areas, and City facilities at the Berkeley Marina. This project includes a comprehensive upgrade and replacement of the aging electrical infrastructure, and compliance with the most current electrical codes. In addition the project includes repair of the dry rot infected wood members at the Marina Corporation Yard Maintenance Building.

In October 2018, City staff authorized the City's on-call structural consultant, IDA Structural Engineers, and the City's on-call electrical consultant, Interface Engineering, to develop the contract documents to incorporate the improvements for durable and safe facilities.

The provided services will support the Strategic Plan goals of creating a resilient, safe, connected, and prepared city and providing state-of-the-art, well-maintained facilities.

ENVIRONMENTAL SUSTAINABILITY

The project involves upgrades of existing facilities. The new electrical equipment will make the overall electrical network more efficient.

RATIONALE FOR RECOMMENDATION

Contracted services are required for this project as the City does not have the in-house resources to complete this specialized work.

ALTERNATIVE ACTIONS CONSIDERED None.

WHEREAS, funds are available in the FY 2020 budget in the Measure T1 Fund 511.



BE IT FURTHER RESOLVED, that the Council of the City of Berkeley authorizes the City Manager to execute a contract and any amendments, extensions or change orders, until completion of the project in accordance with the approved plans and specifications with Alta Group, Inc. for the T1 Corporation Yard Maintenance Building Upgrades at 1326 Allston Way and the T1 Marina Corporation Yard Maintenance Building Upgrade Project at 201 University Avenue, in an amount not to exceed \$1,011,006.
