	Caregiver Registry - assessment and match senior to needed in-home care worker. 6 hours per match as needed, one-on-one in client's home and over phone.

#### **1st Half Narrative**

Due to covid, seniors are not able to come on site and we cannot collect enrollment forms or statistical information from the vast majority of seniors that take wellness classes, or attend educational events and workshops. We are able to collect statistics on people receiving nutrition and case management services but those who participate by Zoom for classes and events are not required to fill out paperwork everytime they participate which is different from the past inperson process.

Overall nutrition service utilization has increased by 30% due to covid. Case management assistance has remained level and the number of people accessing wellness programs and educational events have increased.

We commend your stand and efforts, and wish you success. Berkeley deserves no less.

The purpose of this letter is to ask, that we may be better informed, of the specific efforts you are currently pursuing as well the status of the efforts. This information would enable us to learn how we and the entire Berkeley Community may be of help to ensure that Alta Bates continues to thrive and serve Berkeley without any fear of it being closed whether in 2030 or any future date.

We thank you for your work, and look forward to hearing from you.

We, the undersigned, hope that the HWCA Commissioners will sign the following and send it to the Mayor and Councilmembers.

Dear Mayor Arreguin and Council Members,

It has come to our attention that Council is rearranging certain City of Berkeley Commissions, and that the Peace and Justice Commission may be merged with the HWCAC. Our Commission, HWCAC, has not been consulted on this idea, nor asked for feedback, comments, or suggestions. In case this rumor has some validity, we would like to voice our objection based on the following reasons:

1) The resulting Commission will be too large, unwieldy and divisive.

2) At present we have a dynamic and cohesive group of Commissioners who are working well together. We are united in our commitment to addressing the needs of those Berkeley citizens who are marginalized and/ or require special targeted services due to one or more of the following:

Age Disabilities Food and Housing insecurity Educational disparities Poverty Health Access Personal Safety

*3)* The HWCAC is a mandated Commission, deserving a special designation and opportunity to provide counsel and "eyes in the ground" for our most deserving residents.

4) The Peace and Justice Commission tends to focus largely on National and International concerns and goals.

Please assure us that you will respect our Commission, missions and concerns in its current form.
