At an on-site meeting at North Berkeley BART on March 5, one member of the developer team said they wanted to divert bicycles from the Ohlone Greenway; they want bicyclists who are using the greenway (rather than going to BART) to go up Virginia St. and then use a two-way bike track on Sacramento to get back to the greenway. He also said erroneously that the Virginia St. Bike Boulevard was the main bike route near the station, implying that the greenway is not an important bike route.

In fact, Berkeley's bicycle plan would make the Ohlone Greenway into one of Berkeley's most important bike routes. The bicycle plan calls for protected bike lanes on Hearst between California and Milvia, which would connect the greenway with the protected bike lanes on Milvia St. and on Hearst Ave. east of Milvia, making it the most convenient and safest bike route connecting downtown and the University campus with all the cities to the north.

BART is planning to improve the greenway between Acton and Virginia Gardens and the city of Berkeley is planning to improve the greenway for bicyclists between Virginia Gardens and Gilman. The proposal to divert bicycles from the greenway on the BART development site is inconsistent with these plans.

The greenway should be designed to protect both pedestrians and bicyclists as it goes through the BART development site. The design should separate pedestrian and bicycle lanes on the greenway (as Albany and El Cerrito do.) And the design of the greenway through the BART development should slow bicyclists, since it will be heavily used by pedestrians there.

But it is totally unacceptable to make it so inconvenient to bicycle through the BART site on the greenway that bicyclists will be forced to divert to Virginia and Sacramento St, making this major regional bike route less effective.

In the developers' preliminary design, the greenway has such extreme meanders as it goes through the development that it would clearly be unusable as a through route for bicycles. This design must be corrected so the greenway protects pedestrian safety while accommodating people both walking and biking.

Dear Mr. Javandel,

I would like to engage with you and the Transportation and Infrastructure Commission regarding the long-term vision for Berkeley's network of bicycle boulevards. As an avid bicyclist and pedestrian, I am very familiar with the current citywide routes. I would like to give specific input regarding bike lane infrastructure within the city's southern diistrict neighborhoods.

I first participated in the public process that recommended a network of seven bicycle boulevards in the 1990's. In my District 3 neighborhood, we identified Russell, Milvia, and California Streets to be included in the initial plan. We participated in work groups to develop a "tool box" of possible solutions for infrastructure improvements.

It has been my pleasure to watch those visions come to fruition in recent years. I am grateful to Berkeley's dedicated staffand commissioners, and for the City Council's support and leadership to fund implementation. I am also proud of the Berkeley voters who passed the necessary bond measures.

Now as you move forward with next stages of planning, I would like to recommend Blake Street be identified as a potential east-west route in the bike boulevard network. It "checks some boxes" in the list of desired criteria for such designation, including close proximity to a main traffic artery, Dwight Way. On the blocks west of Shattuck Avenue, it also is wider than most streets and thus could more easily accommodate bike lanes. Furthermore I would like to focus specific attention on the Blake/Milvia Streets intersection, as newer housing developments and one-way traffic flow will impact pedestrian and bicycle safety there.

I am hoping to attend the commission's March meeting.
