


Active Transportation Program Overview

- ATP is a Caltrans-managed funding program to encourage increased use of active modes of transportation.
- ATP Cycle 7 is expected to include about \$568M made up of Federal, State SB1, and State Highway Account (SHA) funding.
- The funding/programming years include the 25/26, 26/27, 27/28, and 28/29 fiscal years.
- Program categories include plans, infrastructure, non-infrastructure, and quick-build.
 - Southwest Berkeley Bike Boulevards will be a medium infrastructure project
 - Adeline St Quick-Build will be a quick-build project, which provides funding for construction only for low to moderate cost materials. This project type allows for some adjustments to be made in response to community input.

Adeline Street Cycle Track Quick-Build

Location: Adeline Street from Ashby Ave to Martin Luther King Jr Way/Stanford Ave intersection.

Construction: would reduce the number of through lanes from six to four lanes (two in each direction) and accommodate construction of a one-way protected bike lane ("cycle track") on each side of Adeline Street.

Background: Adeline Street is a high-injury street for severe and fatal traffic crashes involving walking and biking (2020 Berkeley Vision Zero Action Plan and the 2020 Berkeley Pedestrian Plan). Oakland DOT is currently planning a cycle track starting at the Berkeley border on Martin Luther King Jr Way that would connect to this project and create a continuous protected bike lane between these cities.

Other design details: Includes concrete bus boarding islands at three to four locations in the project area.

Implements Council-Adopted Plans:

- The 2017 Bike Plan identified Adeline St as a Tier 1 Priority Project
- The 2020 Vision Zero Action Plan and 2020 Pedestrian Plan identified Adeline as a High Injury Street
- The 2020 Adeline Corridor Specific Plan identified key objectives for improving cyclist and pedestrian safety on the corridor, including reducing crossing distances and studying cycle tracks on Adeline
- The 2023 Transit First Implementation Plan identifies bus boarding islands as transit-supportive infrastructure

Southwest Berkeley Bike Boulevards

ATP requires that 11.47% of the total grant funding request be available as local matching funds for projects.

Required matching funds in the amount of \$563,900 are available starting in fiscal year 2028 from Measure BB Fund 134 (Bicycle and Pedestrian) and Fund 134 (Local Streets and Roads).







Berkeley Considerations

Benefits of Standard-gauge (Regional Rail):

- Potential new urban metro service (10 min frequency or better) at existing West Berkeley station that connects to the inner East Bay, San Francisco, and the Peninsula
- Complementary to new and existing land use development in West Berkeley
- Faster travel times between West Berkeley, Oakland, potentially Alameda, and San Francisco
- Connect West Berkeley to BART network at new transfer station in Downtown Oakland
- Potential for improvements to existing at-grade rail crossings along Union Pacific rail corridor

Benefits of Broad-gauge (BART):

- Increased frequency of BART service at Berkeley BART Stations
- Potential new service to Alameda and Mission Bay in San Francisco

Berkeley Considerations (cont'd)

Benefits of both technologies:

- Improved access to jobs and destinations for Berkeley residents
- Supports Berkeley land use and transportation goals
- Improved safety, health, and air quality
